LAND BACK LEGACY

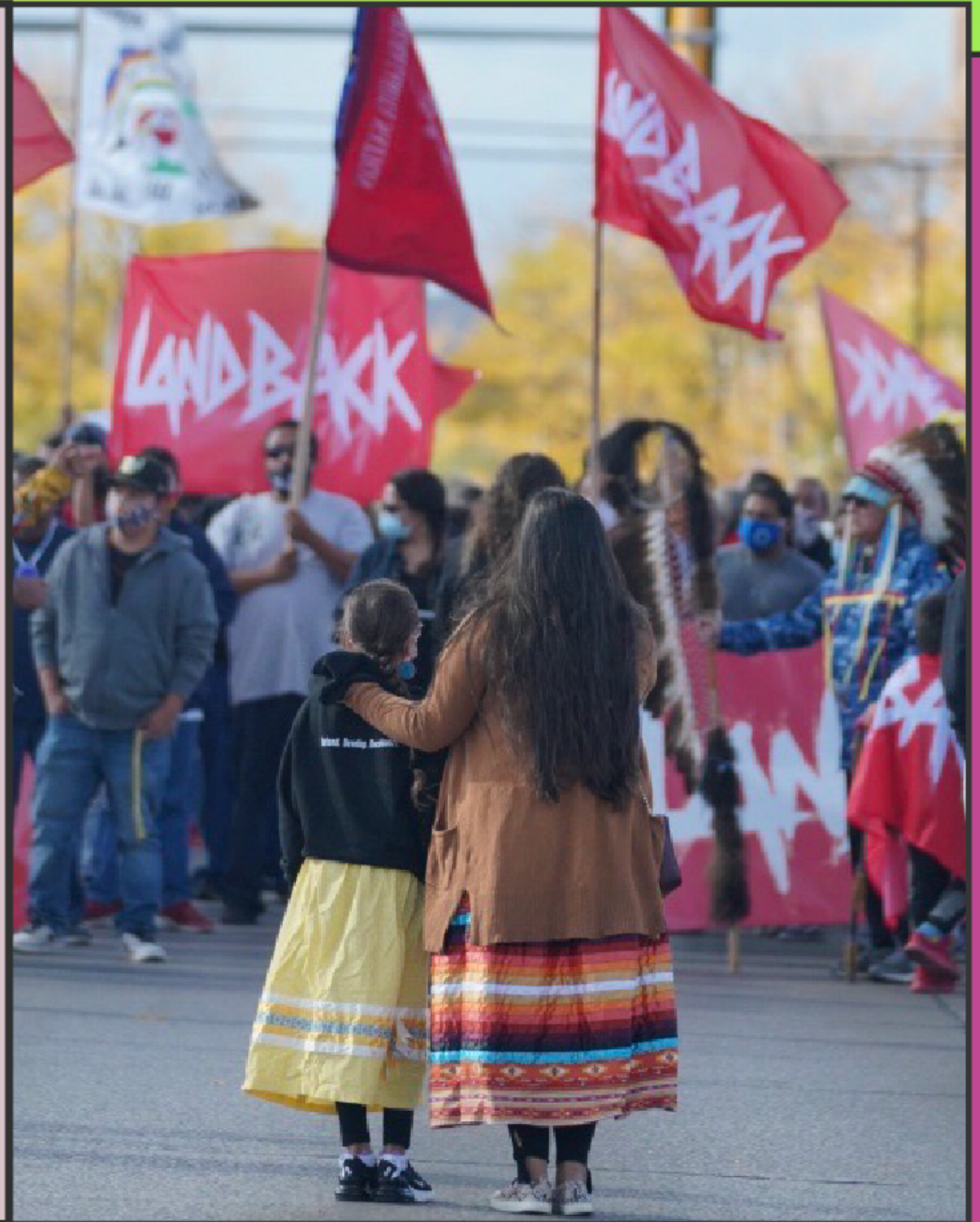


The legacy of Indigenous resistance through direct action to reclaim land and stop desecration of sacred sites is centuries old, from the Pueblo Revolt of 1680 in New Mexico to the take back of Alacatzraz in 1969, and countless more examples.

LAND BACK LEGACY

“Our people have been fighting for land back and to reclaim lands since colonization... this work has been happening for generations and generations and it’s something that’s simply being handed down to us.”

From Oceti Sakowin water protectors stopping the Dakota Access Pipeline in 2016 to the 2020 protests to defend He Sapa and return the land to its original stewards — fierce resistance by land and water protectors in recent years has amplified the generations-long call for Land Back.

LAND BACK IN ACTION: SOGOREA TE'

In 2011 a coalition of Native people and their allies took back Sogorea Te, a Karkin Ohlone sacred site, for 109 days of ceremony to stop a proposed development. This occupation was built on decades of work to protect and preserve sacred sites of the Bay Area and led to the creation of the Sogorea Te' Land Trust.

LAND BACK IN ACTION: SOGOREA TE'



Now as an urban Indigenous women-led land trust, STLT is stewarding small plots of land for cultural revitalization work including growing ancestral foods and medicines, holding traditional ceremony, and building community resilience centers.

City Returns a Stolen Island to a Native Tribe

The Wiyot Tribe was driven from California's Duluwat Island in 1860. After decades of lobbying by the tribe, the Eureka City Council returned it.
